## Clearbrook Global Advisors' CEO Elliott Wislar Kicks Off Opal Group's Public Funds Summit East Event

In Mr. Wislar's opening remarks, he said, "In the past few years, we have seen a number of public funds completely redeem from their hedge fund program. However, when we look at the assets in the terminated hedge fund programs as a percentage of the overall plan assets, hedge funds were not a very large percentage of the plan to begin with." He added, "Every public pension plan is different, with different investment objectives and tolerance for risk. But in general, when we work with our clients, we

believe strongly that all asset classes should be considered to build a diversified and effective portfolio."

With approximately 1500 attendees, the event attracted pension representatives, consultants, attorneys, hedge funds, fund of funds, insurance companies, private equity, and benefit companies. The annual conference promoted the exchange of ideas both in and out of the session halls in order to educate and identify viable alternatives that can address the concerns of those involved in the public funds industry.
